HACB celebrates announcement of tax credit awards totaling \$30 Million Dollars to continue focusing on Housing,

People and Communities

Awarding of 9% Tax Credits to construct two LIHTC RAD Communities

BROWNSVILLE, TX SEPTEMBER 20, 2019—The Housing Authority of the City of Brownsville (HACB) hosted two momentous events on Wednesday, September 18th. The day began with the groundbreaking ceremony of our 21st property, Poinsettia Gardens at Boca Chica located at 341 Oak Street—adjacent to HACB's Main Office on Boca Chica Boulevard. Poinsettia Gardens at Boca Chica (PGBC) is a 20 million-dollar 9% tax credit awarded by the Texas Department of Housing and Community Affairs (TDHCA) in 2018. This one of a kind 15.1-acre property will consist of one hundred and fifty units comprised of 1, 2, and 3-bedroom options, available with 100% Rental Assistance Demonstration (RAD) vouchers. Programs maximized and leveraged were HUD's Choice Neighborhood Initiative, HUD's Rental Assistance Demonstration (RAD) Program and TDHCA's 9% tax credit program. HACB is the only public Housing Authority in Texas that has leveraged all three programs to develop new affordable housing. This specific tax credit award and project is very special due to it being born from community engagement. Our families and community partners contributed to the planning of this project, a two-year planning process under the Buena Vida Choice Neighborhood Planning project. Our families and community stakeholders took an active engaged role in identifying PGBC as phase one of the Housing Strategy outlined in the Buena Vida Choice Neighborhood Plan. PGBC is the beginning to the revitalization efforts that will be brought to the Buena Vida and Downtown District. Construction is scheduled to finish on December of 2020.

Following into the afternoon, a celebration for the 2019 9% tax credit award of 9.9 million-dollars for the construction of our 22nd property Trail Village took place at the Bougainvillea Development located on Jefferson Street. This 4.85-acre housing property to be located off of Paredes Lane and Paseo Plaza Boulevard (behind the Paseo Plaza Apartments) will consist of forty-eight units comprised of 1, 2, and 3-bedroom mix options, available with 100% Rental Assistance Demonstration (RAD) Voucher property. Programs maximized and leveraged were HUD's Rental Assistance Demonstration (RAD) Program and TDHCA's 9% tax credit program. HACB's strategy is to build new modern developments by leveraging the HUD RAD Voucher Program with the tax credit program. HUD has approved to transfer the HUD RAD Voucher assistance from Bougainvillea to Trail Village. The Bougainvillea Housing Development was built in 1940 and it is the second oldest housing development in Brownsville. Construction for Trail Village is projected in the summer of 2020 and will conclude during the Fall of 2021.

A heartfelt thanks to our distinguished speakers for their participation and support towards building new affordable housing opportunities in our community.
